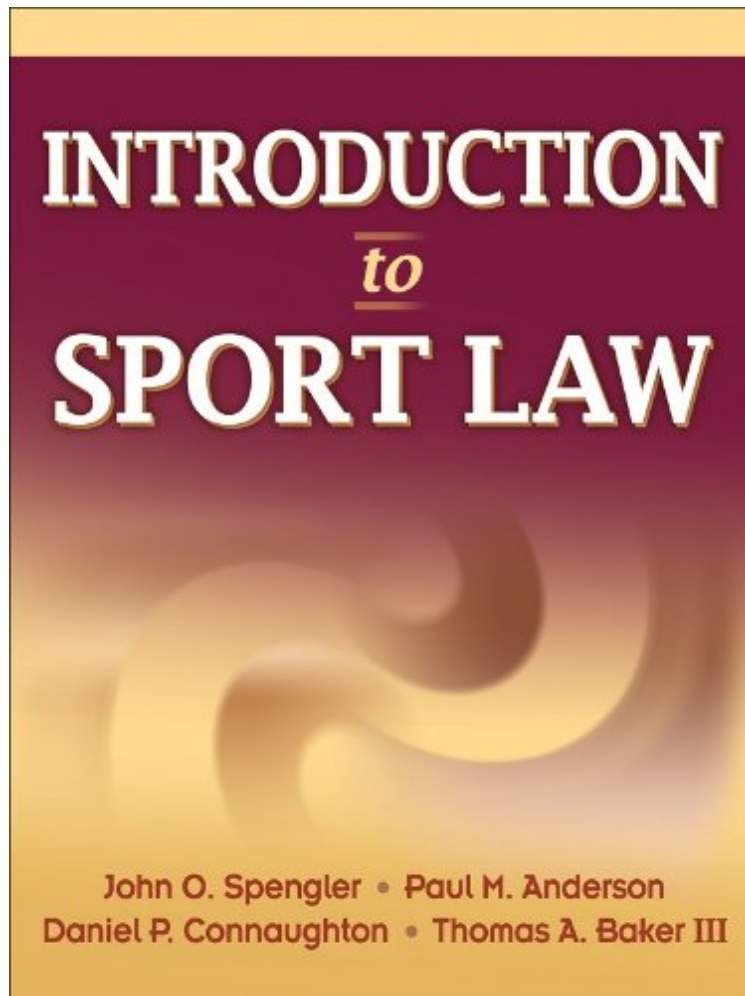

Spengler, JD, PhD, is an associate professor in the College of Health and Human Performance at the University of Florida at Gainesville. Spengler received his law degree from the University of Toledo in 1992 and his doctorate in recreation administration from Indiana University in 1999. Using his experience and education in both of these fields, Spengler has written, taught, and consulted on all aspects of legal issues in sport and recreation safety, risk management, and recreation and sport. He has published numerous articles in scholarly and practitioner journals and three textbooks on sport and recreation legal issues, including a sport law casebook. Spengler is a member of the American Alliance for Health, Physical Education, Recreation and Dance (AAHPERD) and serves as chair of the AAHPERD, AAPAR Safety, and Risk Management Council. He is also a member of the National Recreation and Park Association, American College of Sports Medicine, and the Sport and Recreation Law Association. In 2002, Spengler became a research fellow for AAHPERD. He was also named Teacher of the Year in 2003 by the College of Health and Human Performance at the University of Florida and was twice recognized in Who's Who Among America's Teachers.
