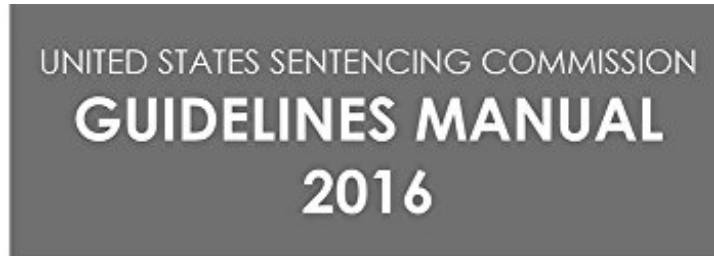

establish education and research programs.
